BUILDING INFORMATION CARD

The second part of the DSSI Emergency Preparedness for Residential High Rise Buildings involves the creation of a Comprehensive Building Information Card (BIC), which is a document that FDNY First Responders need any time they are called to a Property. This document is designed as a quick-reference for the First Responders in a familiar format.



The BIC includes information about the Building, and includes: Stairways, Elevators, Building Ventilation, Utilities, Fire Protection Systems, Hazardous Materials Locations and Property Management Contact Information. It also includes Contact Information for the Local Fire House, Police Department and the nearest Hospital Facility.

STAFF TRAINING
